SuMPay System Update

Six months in the new SuMPay System!!
There are changes coming in April for Warrants

➤ **WARRANT MAILING PROCEDURES:**

Starting in April 2023, we will begin utilizing the Louisiana Statewide Mailroom to print and mail the warrants. We will start with a test run of the Marshal's, Constables and JOP Warrants in April and expand to include Fire and Police in May and June.

➤ **WHAT WILL THIS MEAN FOR YOU:**

The envelope will look different. Depending on the number of pages, your warrant may fit in a regular #10 white envelope. Warrants that have more pages will be mailed in a white craft envelope. All envelopes will have a window for the address. There will be a flyer page on the front of the warrant with your address.

➤ **WHAT YOU SHOULD DO TO PREPARE:**

Take extra time to review March's warrant to ensure we have all the correct information in the SuMPay System.

- Make sure that all your recipients are listed on the Warrant
- Make sure that all the changes you reported last month are reflected on this month's Warrant
- Review the Job Titles printed on the Warrant, verify it is the correct Job Title and mark any changes on the Warrant in RED
- Review the Preparer, Approver, and Certifier names and contact information and mark any changes on the Warrant in RED.
- Verify your mailing address and mark any changes on the Warrant in RED

➤ **FUTURE CHANGES:**

Over the next few months we will be sending out forms to enroll in Electronic Warrants by e-mail. This will be the next step in improving the Warrant and Payment processes. And next month we will begin updating and revising the documents and forms on the website. Go take a look!!
