Any correspondence, communications, or records received from the Office of the District Attorney for the 16th Judicial District indicating that they have completed their investigation into the same allegations described in request number 1.

· **Request No. 5:**

Any correspondence, communications, or records received from the Office of the Attorney General for the State of Louisiana indicating that they have completed their investigation into the same allegations described in request number 1.
