AN EXTRACT OF THE MINUTES OF THE PARISH COUNCIL OF IBERIA PARISH, LOUISIANA, TAKEN AT A REGULAR MEETING HELD ON WEDNESDAY, APRIL 23, 2025.

A motion was made by Mr. Francis "Tommy" Pollard, Sr., seconded by Mr. Scott Ransonet, that the following be adopted:

RESOLUTION NO. 2025-85

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE IBERIA PARISH GOVERNMENT AND 16TH JUDICIAL DISTRICT ATTORNEY'S OFFICE IN CONNECTION WITH \$325,000 IN OPIOID RELATED EXPENSES ALREADY APPROPRIATED IN THE 2025 OPIOID FUND BUDGET FOR THE YEARS OF 2022, 2023 AND 2024; TO PROVIDE FOR THE EFFECTIVE DATE THEREOF; AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, Iberia Parish Government receives funding from the national opioid settlement; and

WHEREAS, the State of Louisiana through the Louisiana State - Local Government Opioid Litigation Memorandum (MOU) provides sets forth approved purposes for the funding to be used; and

WHEREAS, Iberia Parish Government has appropriated in the 2025 Opioid Fund Budget settlement funds in the amount of \$325,000 to the 16th Judicial District Attorney's Office for reimbursement for 2022, 2023, and 2024 uses in accordance with the MOU; and

WHEREAS, it is necessary to authorize the execution of a Cooperative Endeavor Agreement with the 16th Judicial District Attorney's Office to provide the terms and conditions for said funding and any future opioid settlement funding which shall include reporting requirements and indemnification of Iberia Parish Government.

BE IT FINALLY RESOLVED, that this Resolution shall become effective immediately upon adoption by the Iberia Parish Council and approval by the Parish President in accordance with Section 2-13 of the Iberia Parish Home.


