Count 1: On or about 09/11/2014, in the Parish of Lafayette, CHASE SAMUEL CHAISSON did attempt to commit first degree murder of one, OFFICER KARL RATCLIFF, in violation of the provisions of R. S. 14:27(30).

Count 2: On or about 09/11/2014, in the Parish of Lafayette, CHASE SAMUEL CHAISSON being a person having been convicted of a felony, to-wit: ATTEMPTED PWITD COCAINE, DOCKET NUMBER 130303, State of Louisiana, Parish of Lafayette, on DECEMBER 30, 2013, did willfully and unlawfully possess a firearm, in violation of the provisions of R.S. 14:95.1.

Count 3: On or about 09/11/2014, in the Parish of Lafayette, CHASE SAMUEL CHAISSON did forcibly and seize and carry one JENNIFER FETT from one place to another and/or did imprison or forcibly secrete her, wherein said JENNIFER FETT was physically injured, in violation of the provisions of R.S. 14:44.1.

Count 4: On or about 09/11/2014, in the Parish of Lafayette, CHASE SAMUEL CHAISSON did intentionally inflict great bodily harm to one police dog, owned by LAFAYETTE CITY POLICE DEPARTMENT and used in the detection of criminal activity, enforcement of laws or apprehension of offenders, in violation of the provisions of R.S. 14:102.8.


