

**AN ORDINANCE AMENDING ORDINANCE 2003-5 TO ADOPT A SALARY SCHEDULE FOR CITY COUNCIL MEMBERS**

**WHEREAS**, the City Council for the City of Scott, Louisiana, desires to amend ordinance number 2003-5, which establishes and adopts a salary schedule and employee pay plan for the employees of the City of Scott, Louisiana, in order to adopt a new salary schedule for City Council members; and

**WHEREAS**, the salary for the position of Councilman at Large (Mayor Pro Tempore) shall be the sum of \$1,400.00 per month, and the salary for the other council members shall be the sum of \$1,000.00 per month;

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and the City Council for the City of Scott, in regular session assembled, that City of Scott ordinance number 2003-5 is hereby amended as follows, to wit:

**SECTION 1:** All of the aforescribed "Whereas" clauses are adopted as part of this ordinance.

**SECTION 2:** The salary for the position of Councilman at Large (Mayor Pro Tempore) shall be the sum of \$1,400.00 per month.

**SECTION 3:** The salary for City Council members, other than the Councilman at Large (Mayor Pro Tempore), shall be the sum of \$1,000.00 per month.

**SECTION 4:** This ordinance shall become effective on July 1, 2019.

**SECTION 5:** All ordinances or resolutions, or parts thereof, in conflict herewith, are hereby repealed.


