It is of particular interest that Chief Glover relies on CALEA standards in the filing of his appeal, while appearing to disregard those pertaining to the conduct of administration investigations – “A written directive ***requires all complaints against the agency or its employees be investigated***, to include anonymous complaints.” (CALEA 52.1.1)

These items are again being brought to the attention of the Lafayette Municipal Fire & Police Civil Service Board for investigation and any other actions deemed proper and appropriate by the Board within their statutory authority.

ADDENDUM A

NOW COMES Michael Lunsford, who seeks to amend and supplement his original verified complaint of June 21, 2021 with the following additional paragraphs/details:

5A.

On September 30, 2021 an *in camera* inspection of file materials concerning Michael Brown was allowed which included, but was not limited to the items below.

- 1) An Internal Affairs Complaint form dated January 4, 2021 indicating the investigation was assigning to Chasity Arwood;
- 2) A letter dated September 29, 2021 from Attorney Michael P. Corry, Sr. stating: "The Internal Affairs Unit of the Lafayette Police Department and Chief Glover have no internal investigation file on this incident. A criminal investigation was conducted and is currently awaiting grand jury review. Therefore, there is no Internal Affairs file to review"; and
- 3) Body camera footage containing a date stamp of November 12, 2020.

5B.

Based on information and belief, an investigation was not conducted into the incidents described in paragraph 1 and paragraph 3 of the original verified complaint of June 21, 2021.

5C.

Based on information and belief, the following documents and information, or lack thereof, from the file materials presented at the *in camera* inspection support the conclusion that an investigation was not conducted into the incident described in paragraph 1:

- 1) There was no Internal Affairs case number assigned to the matter;
- 2) There was no record of any investigation appearing on the Internal Affairs "Concise Officer History" of Michael Brown generated on April 21, 2021 (**Exhibit B**);
- 3) There was no record of any investigation appearing on the Internal Affairs "Concise Officer History" of Michael Brown generated on November 10, 2021 (**Exhibit D**);
- 4) There was no investigative report completed detailing the allegations and the result of the investigation;
- 5) There was no recorded or written statements; and
- 6) There was no Police Officer Bill of Rights forms executed.

5D.

Based on information and belief, the following documents and information, or lack thereof, from the file materials presented at the *in camera* inspection support the conclusion that an investigation was not conducted into the incident described in paragraph 3:

- 1) A letter dated September 29, 2021 from Attorney Michael P. Corry, Sr. stating: "The Internal Affairs Unit of the Lafayette Police Department and Chief Glover have no internal

investigation file on this incident. A criminal investigation was conducted and is currently awaiting grand jury review. Therefore, there is no Internal Affairs file to review”;

- 2) There was no Internal Affairs case number assigned to the matter;
- 3) There was no record of any investigation appearing on the Internal Affairs “Concise Officer History” of Michael Brown generated on April 21, 2021 (**Exhibit B**);
- 4) There was no record of any investigation appearing on the Internal Affairs “Concise Officer History” of Michael Brown generated on November 10, 2021 (**Exhibit D**);
- 5) There was no investigative report completed detailing the allegations and the result of the investigation;
- 6) There was no recorded or written statements; and
- 7) There was no Police Officer Bill of Rights forms executed.

5E.

Based on information contained in the public record on or about March 29, 2021 a complaint of officer misconduct against Lafayette Police Department Officer Michael Brown was assigned for investigation. The complaint is assigned internal affairs number 2021-017. Despite the investigation being received on March 29, 2021 it did not appear in the Internal Affairs “Concise Officer History” generated on April 21, 2021 (**Exhibit B**). Nor does the Internal Affairs “Concise Officer History” generated on November 10, 2021 (**Exhibit D**) contain any information with regards to the allegations against Michael Brown. It is unknown why this investigation was delayed, concealed or otherwise not listed on the Internal Affairs “Concise Officer History” generated on April 21, 2021.

5F.

The deadlines for completion of the investigation into the March 29, 2021 allegations against Jarvis Mayfield have lapsed, absent any extension of time granted by this Board (Ref. Louisiana Revised Statute 40:2531(7)).

5G.

Based on information contained in the public record on or about February 24, 2021 a complaint of officer misconduct was lodged against Lafayette Police Department Officer Jarvis Mayfield. The complaint is assigned internal affairs number 2021-011. As of October 25, 2021 the concise officer history for Jarvis Mayfield (**Exhibit E**) does not contain any information concerning the specific allegations against the officer or the disposition of the complaint.

5H.

The deadlines for completion of the investigation into the February 24, 2021 allegations against Jarvis Mayfield have lapsed, absent any extension of time granted by this Board (Ref. Louisiana Revised Statute 40:2531(7)).

5I.

Based on information contained in the public record on or before October 2, 2021 Lafayette Police Department Officer Todd Alcorn lost his weapon (**Exhibit F**).

5J.

Based on information contained in the public record there is no disciplinary action or investigation into the incident contained on the Internal Affairs “Concise Officer History” for Todd Alcorn generated on October 25, 2021 (**Exhibit G**).

5K.

Based on information and belief there exist a pattern, practice and custom of the Chief Thomas Glover failing to adequately and properly investigate allegations of employee misconduct and a failure to adequately and properly monitor and discipline his officers.

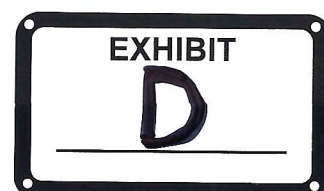




