## Request No. 3:

Any and all records of an internal investigation which was the result on an incident involving the 'stealing of video evidence' in which Shayna Bolgiano was involved or mentioned in as referenced by Chief Boudreaux during the March 30, 2023 special meeting of the City Council.

## Request No. 4:

Any and all training records for Chief Boudreaux pertaining to standardized field sobriety tests (SFST) certification as referenced by Chief Boudreaux during the March 30, 2023 special meeting of the City Council.
