CONSIDERING the Motions to Strike, Memoranda In Support and In Opposition, Law, Exhibits, and Argument of Counsel and for the reasons assigned in open court:

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that the Special Motions to Strike filed pursuant to La. Code of Civil Procedure Article 971 by Defendant Ryan Thames and by Defendants Citizens for a New Louisiana and Michael Lunsford, are GRANTED dismissing with full prejudice the claims of Plaintiff against Defendants Ryan Thames, Citizens for a New Louisiana, and Michael Lunsford.
