Also a small clear container with 17 xanax bars white in color 4 green ovile shaped Alprazolam and 8 round purple unkown substance that with be later tested. I then moved a bag that looked like a monkey and seen the marijuan two bags and the paraphernalia a scale with the shape of a marbrole cigerette box and sizzers.


