Against the peace and dignity of the State of Louisiana The affiant charges that the accused committed the above described offense based on the following information

ON JUNE 22, 2021 WHILE INVESTIGATING A PHONE DUMP OBTAINED FROM AN EXECUTED SEARCH WARRANT SIGNED BY JUDGE VINCENT BORNE ON NOVEMBER 19, 2020 AT 1003 DEVILLIER ST HENDERSON LA 70517 CASE NUMBER 20-HP-2463 WHERE METHAMPHETAMINE WAS RECOVERED FROM MULTIPLE SUSPECTS ALONG WITH FIREARMS AND DRUG PARPHERNALIA WHILE INVESTIGATING THE FORENSICALLY DOWNLOADED ELECTRONIC DEVICES RECOVERED FROM THE SEARCH WARRANT IT WAS LEARNED THAT MORE THAN NARCOTICS TRANSACTIONS WERE ON THE ON SOME OF THE DEVICES RECOVERED ANOTHER SEARCH WARRANT WAS APPLIED FOR AND GRANTED FOR SAID DEVICES DUE TO POTENTIAL HUMAN TRAFFICKING BEING OBSERVED AS THE ORIGINAL SEARCH WARRANTS WERE FOR NARCOTICS RELATED INFORMATION ONLY OFFICER BROUSSARD BEGAN SIFTING THROUGH THE DATA WHICH LED TO THE IDENTIFICATION OF THE LISTED SUSPECT THROUGH 911 PHONE RECORDS. IT WAS OBSERVED IN ELECTRONIC COMMUNICATION THAT JASON DAIGLE AT THE REQUEST OF JOSE ARMENTA COMMITTED THE ABOVE LISTED CRIMINAL ACTS. THE FOLLOWING ARE A SYNOPSIS OF THE INTERVIEWS CONDUCTED WITH JASON DAIGLE AND BRITTANIE AUCOIN IN REFERENCE TO ELECTRONIC COMMUNICATION ON THE DEVICES. THESE INTERVIEWS WERE CONDUCTED TO COOPERATE THE EVENTS THAT WERE PLANNED, FACILITATED AND STARTED INSIDE THE HENDERSON CITY LIMITS

ON AUGUST 20 2021 AT APPROXIMATELY AT 1944 HOURS OFC RANDLE BROUSSARD MET WITH JASON DAIGLE WHITE MALE DATE OF BIRTH 08-23-1970 JASON CAME TO HENDERSON POLICE DEPARTMENT TO CONDUCT A VOLUNTARY INTERVIEW IN REFERENCE TO PAST CRIMES INVOLVING JOSE GARCIA ARMENTA (AKA MIGO) JASON WAS ADVISED OF HIS CONSTITUTIONAL RIGHTS VIA MIRANDA, TO WHICH HE ADVISED HE UNDERSTOOD AND AGREED TO SPEAK

WITH OFFICER BROUSSARD. JASON WAS GIVEN RIGHTS FORM WHICH HE READ AND SIGNED AGREEING TO SPEAK WITH OFFICER BROUSSARD. OFC BROUSSARD ASKED JASON ABOUT HIS DEALINGS WITH JOSE ARMENTA IN REFERENCE TO JASON FACILITATING A TRANSACTION BETWEEN JOSE ARMENTA AND BRITTANIE AUCOIN WHITE FEMALE DOB 9-12-1990. JASON DAIGLE POST MIRANDA VERBAL AND WRITTEN STATED HE "HOOKED THEM UP". JASON PICKED UP JOSE ARMENTA FROM HENDERSON AND BROUGHT HIM TO THE BLUE MOTEL (AMERICA'S BEST HOTEL AND SUITES) IN BREAUX BRIDGE IN FRONT OF WALMART. DROPPED HIM OFF THEN PICKED UP BRITTANIE WHO IS IN JASON'S OWN WORDS "FAMILY TO HIM" AND DROPPED HER OFF TO MEET JOSE AND NEGOTIATE SEX FOR METHAMPHETAMINE AND MONEY ON 11-30-2020. JASON ADVISED HE WAS SCREWED OUT OF HIS MONEY BECAUSE SOMETHING HAPPENED AND HE DIDN'T GET HIS MONEY. JASON ADVISED BRITTANIE WAS TO GIVE HIM MONEY FROM THE TRANSACTION WITH JOSE ARMENTA. BOTH JASON AND JOSE ARE IN VIOLATION OF LOUISIANA REVISED STATUTE 14:46.A.1 HUMAN TRAFFICKING BY ACTIVELY RECRUITING AND ENTICING BRITTANIE TO ENGAGE IN SEXUAL ACTS PER JOSE ARMENTA'S REQUEST TO JASON IN EXCHANGE FOR MONEY AND METHAMPHETAMINE. BOTH JASON AND JOSE VIOLATED LOUISIANA REVISED STATUTE 40 967 A.1 DISTRIBUTION OF SCHEDULE II NARCOTICS (METHAMPHETAMINE.) BOTH JASON AND JOSE ALSO VIOLATED LOUISIANA REVISED STATUTE 14.26 CRIMINAL CONSPIRACY, THE OVERT ACT BEING JASON DAIGLE FACILITATED THE MEETING BETWEEN ARMENTA AND BRITTANIE BY PICKING UP BOTH PARTIES AND DRIVING THEM TO THE ARRANGED MEETING LOCATION AMERICA'S BEST HOTEL AND SUITES. JASON VIOLATED LOUISIANA REVISED STATUTE 14.66 EXTORTION ON 12-3-2020 BY TEXTING ARMENTA WHERE HE STATED "HEY SHE SAID YOU HURT HER AND SHE GOT TO GO TO THE DOCTOR SHE SAID SHE WANTS \$200 AND TWO EIGHT BALLS" THEN TEXT SHE WANTS \$300 AND 2BALLS OR SHE GOING TO THE COPS." JASON COMPLETED A VOLUNTARY STATEMENT AND ADVISED HE WOULD GET BRITTANIE TO COME FORWARD AND SPEAK WITH OFC BROUSSARD. JASON AND HIS MOTHER WHO WAS PRESENT DURING HIS INTERVIEW HAVE BEEN AROUND BRITTANIE MULTIPLE TIMES AND HAVE NOT ATTEMPTED TO HAVE HER SPEAK WITH OFC BROUSSARD.

ON 9-9-2021 AT 2208 HOURS BRITTANIE AUCOIN (DOB 9-12-1990) THE VICTIM OF THE ABOVE LISTED CRIMINAL ACTS ARRIVED AT HENDERSON POLICE DEPARTMENT TO VOLUNTARILY SPEAK WITH OFFICER BROUSSARD ABOUT THE ALLEGED INCIDENTS. BRITTANIE WAS ADVISED OF HER CONSTITUTIONAL RIGHTS PER MIRANDA AND GIVEN A RIGHTS FORM TO READ WHICH SHE DID AND ADVISED SHE UNDERSTOOD AND SIGNED AGREEING TO SPEAK WITH OFFICER BROUSSARD. BRITTANIE BEGAN BY CLEARING UP AN ACCUSATION MADE BY HER FATHER ABOUT HER POSSIBLY BEING RAPED RECENTLY WHILE IN THE CITY LIMITS OF HENDERSON. BRITTANIE ADVISED SHE WAS NOT RAPED SHE WAS WITH HER ON AND OFF AGAIN BOYFRIEND YELLOW (FRANCISCO HELAIRE) WHO WATCHED OVER HER THE ENTIRE TIME SHE WAS PASSED OUT FROM ALCOHOL CONSUMPTION. BRITTANIE WAS ADVISED BY OFC BROUSSARD HE WOULD BE ASKING QUESTIONS IN REGARDS TO PAST EVENTS SPECIFICALLY LAST YEAR WHEN SHE WAS PROPOSITIONED BY JASON DAIGLE TO MEET WITH ANOTHER MALE. BRITTANIE ADVISED SHE WAS HOMELESS AT THE TIME AND WAS IN A TOUGH SPOT AND THAT JASON PREYED UPON HER NEED FOR MONEY. BRITTANIE ADVISED THAT JASON MESSEGED HER ON THE MORNING OF 11-30-

2020 SAYING HE HAD A WAY FOR HER TO MAKE SOME QUICK CASH JASON PICKED HER UP WITH "RA" A MEXICAN WITH BLACK HAIR (JOSE ARMENTA) ALREADY IN THE VEHICLE. WHERE JASON TRIED TO TAKE HER AND ARMENTA TO THE CABINS ON THE BAYOU IN BREAUX BRIDGE. BRITTANIE ADVISED SHE REFUSED TO GO THERE SO THEY WENT TO THE BLUE HOTEL IN BREAUX BRIDGE (AMERICA'S BEST) WHERE JASON CONVINCED BRITTANIE TO GET DOWN AND ENTER THE ROOM WITH JOSE ARMENTA AND HIMSELF. JASON THEN LEFT BRITTANIE ALONE WITH ARMENTA LEAVING THE LOCATION BRITTANIE STATED "RA THE MEXICAN FLASHED A POUND DOPE (METHAMPHETAMINE) OUT ON ME " BRITTANIE STATED "HE THEN GRABBED ME AND TRIED TO TOUCH ME SEXUALLY" AT THIS TIME BRITTANIE CALLED JASON TO FIND OUT WHERE SHE STATED "HE WAS HE SAID HE WAS COMING, AND I TOLD HIM HURRY." BRITTANIE THEN ADVISED SHE BEGAN TRYING TO CALM "RA" (JOSE ARMENTA) DOWN BY SAYING "WE ARE FRIENDS, JUST LET ME BE YOUR FRIEND." JOSE HELD ONTO BRITTANIE'S BAG AND SHOULDER AS THEY WENT DOWNSTAIRS WHERE A MANAGER INTERVENED DUE TO ARMENTA SMOKING IN THE ROOM, BRITTANIE ADVISED SHE TOOK OFF TO WALMART AND LEFT OUT OF THE GARDEN CENTER TO SAFETY WHILE CONDUCTING INTERVIEWS ON 9-10-2021 IT WAS LEARNED THAT JASON DAIGLE SINCE HIS INTERVIEW HAS BEEN ADVISING MEMBERS OF BRITTANIE'S FAMILY OF THE CONTENTS OF HIS INITIAL INTERVIEW AS WELL AS SAYING BRITTANIE IS A "SNITCH." OFC BROUSSARD WILL NOTE THAT JASON WAS ADVISED POST MIRANDA HE WOULD BE CHARGED WITH OBSTRUCTION IF HE SPOKE ABOUT THIS INVESTIGATION TO ANYONE, WHICH HE HAS DONE AND THE CHARGE HAS BEEN ADDED TO THIS WARRANT.
