COUNT #1: POSSESSION WITH INTENT TO DISTRIBUTE A SCHEDULE I
CONTROLLED DANGEROUS SUBSTANCE, La. RS40:966.A.(1)
COUNT #2: POSSESSION OF A SCHEDULE II CONTROLLED DANGEROUS
SUBSTANCE, La. RS40:967.C.(2)
COUNT #3: POSSESSION WITH INTENT TO DISTRIBUTE A SCHEDULE IV
CONTROLLED DANGEROUS SUBSTANCE, La. RS40:969.A.(1)
COUNT #4: ILLEGAL POSSESSION OF STOLEN FIREARMS, La. RS14:69.1.A.
COUNT #5: ILLEGAL USE/POSSESSION/CONTROL OF WEAPONS - CRIME OF
VIOLENCE/CDS, La. RS14:95.E.

M. BOFILL DUHE, DISTRICT ATTORNEY for the Sixteenth Judicial District, Parish
of ST. MARTIN, State of Louisiana, charges that:

Count #1: R.S. 40:966.A.(1) POSSESSION WITH INTENT TO DISTRIBUTE A
SCHEDULE I CONTROLLED DANGEROUS SUBSTANCE IN THE PARISH OF ST.
MARTIN, JAVON PETE, on or about October 15, 2020, did knowingly and intentionally
possess with the intent to distribute a Schedule I Controlled Dangerous Substance, to wit:
MDMA.

Count #2: R.S. 40:967.C.(2) POSSESSION OF A SCHEDULE II CONTROLLED
DANGEROUS SUBSTANCE IN THE PARISH OF ST. MARTIN, JAVON PETE, on or
about October 15, 2020, did knowingly and intentionally possess a Schedule II
Controlled Dangerous Substance, to wit: **Methamphetamine**, having an aggregate
weight of two grams or more but less than twenty-eight grams.

Count #3: R.S. 40:969.A.(1) POSSESSION WITH INTENT TO DISTRIBUTE A
SCHEDULE IV CONTROLLED DANGEROUS SUBSTANCE IN THE PARISH OF
ST. MARTIN, JAVON PETE, on or about October 15, 2020, did knowingly and
intentionally possess with the intent to distribute a Schedule IV Controlled Dangerous
Substance, to wit: **Alprazolam.**

Count #4: R.S. 14:69.1.A. ILLEGAL POSSESSION OF STOLEN FIREARMS IN THE
PARISH OF ST. MARTIN, JAVON PETE, on or about October 15, 2020, did possess,
procure, receive, or conceal a firearm which has been the subject of any form of
misappropriation, to wit: **Cobra .380 pistol, serial # FS082449.**

Count #5: R.S. 14:95.E. ILLEGAL USE/POSSESSION/CONTROL OF WEAPONS -
CRIME OF VIOLENCE/CDS IN THE PARISH OF ST. MARTIN, JAVON PETE, on
or about October 15, 2020, did use, possess, or have under his immediate control, any
firearm or other instrumentality customarily used or intended for probable use as a
dangerous weapon, to-wit: **Cobra .380 pistol**, while committing or attempting to commit
a crime of violence or while in the possession of or during the sale or distribution of a
controlled dangerous substance, to-wit: **Methamphetamine,**
