Representing the Petitioner: Halee Maturin, Asst. District Attorney and Alistar Charrier, Asst. District Attorney; and

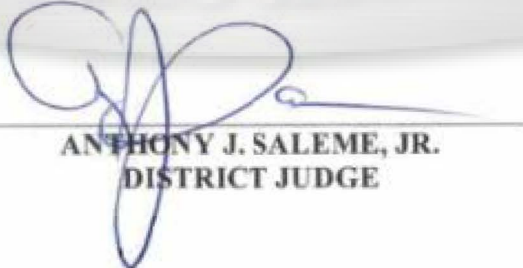
Defendant, Hubert Augustine, and counsel for defendant, Justin Cantu.
